Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to **6.4** tCO_2e by **2027**. This is a reduction of circa **50**%. We will achieve this by switching our lease vehicles to electric versions and also by providing our sales team with an electric vehicle.

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been implemented since the 2023 baseline. The carbon emission reduction we hope to achieve by these schemes equate to **circa** 6.4 tCO₂e, a 50% reduction against the 2023 baseline and the measures will be in effect when performing the contract.

• Lease Electric vehicle for Operatives Team - reduction of circa 6.4 CO₂e

In the future we hope to implement further measures such as:

- LED Lighting in the office areas and storage areas
- Introduction of Solar Energy
- Electric Vehicles
- Continued education on effective recycling use
